Memorandum of Understanding:

This memorandum was drafted in Riyadh on 28/04/24, between the following parties:

- 1- Alfaisal University, based in Al Takhassousi ,Al Zahrawi Street interconnecting with, Riyadh 11533Riyadh, telephone/email 011 215 7777 (hpp@alfaisal.edu). Represented at the signing of the memorandum by the Vice Dean of College of Medicine and the Chair of the Department of Family and Community Medicine, Dr. Baraa Alghalyini, hereinafter referred to as the first party or university.
- 2- Saudi Society for Family and Community Medicine, based in Saudi Arabia, Riyadh, Al-Specialy District, 0114808028 Phone, 0555618155 Mobile, Email 0537720025 (SSFCEM.Riyadh@gmail.com). b (.991) The postcode (11421) is represented by the signature of this memorandum by the President of the Saudi Society for Family and Community Medicine, Dr. Ala bint Mahmoud Bably, hereinafter referred to as the second party.

They are collectively referred to as "parties".

Introduction

Based on Saudi Arabia's vision of 2030 in strengthening the efforts of this blessed country, one of whose focuses is on improving the quality of health services. To contribute to the activation of the role of the Alfaisal University in protecting the community by promoting and developing healthcare awareness in accordance with global best practices.

As one of the tasks of the University is to raise awareness and knowledge in the Kingdom on topics pertaining to family medicine and health awareness. It conducts studies and research to improve healthcare and awareness, as well as provide everything new in prevention and health promotion programs. Believing in the role of The Saudi Association for Family and Community Medicine and its sharing of data with the university to achieve opportunities. Both parties were keen to open the prospects for cooperation and activate communication in order to achieve the public interest and contribute to the achievement of the goals. They agreed to sign a memorandum of understanding, which includes the following:

Article 1:

The above preface is an integral part of this note, read and interpreted with it.

Article II: Duration of the memorandum

- 1- This memorandum shall enter into force from the date of signature for a period of one year, and shall automatically be renewed for a similar period unless either party notifies the other party, in writing, of its wish to terminate at least thirty (30) days prior to the date of expiration.
- 2- If this memorandum is not renewed, work will continue to be done to complete existing and resulting joint programs and actions in accordance with its provisions until the end of these programs and actions.

Article III: Areas of cooperation between the former and the latter:

- 1- Both parties are committed to joint efforts and working together, in an effort to make all healthcare and health awareness in Saudi Arabia reliable.
- 2- The parties work in cooperation in the field of health awareness and empowerment of the general public in the field of family medicine.
- 3- The parties are working to activate International Days campaigns and support volunteer initiatives and opportunities related to family medicine.
- 4- The parties work in cooperation in the field of research, scientific and consultation expertise in family and community medicine departments at the national level.
- 5- The two parties share knowledge and training experiences in the field in order to serve these areas of cooperation.
- 6- The university's role is to provide support in terms of offering the campus as venue for the event, marketing and advertisement, faculty participating as members of scientific steering committee, students as volunteers for any jointly organized events.
- 8- The second party will offer research opportunities to interested students from the university to participate in.
- 9- The second party will offer any potential clinical observership opportunities to students, interns, and graduates from the university.

Article IV: Intellectual property rights

Exchange of information, including documents, databases, research, scientific papers and surveys, taking into account intellectual property rights, and protection of such information and documents.

Article V: Confidentiality

1. Each party undertakes to maintain the confidentiality of the memorandum and not to disclose or leak information arising from its execution to others, whether oral, written, electronic or otherwise, without obtaining the written consent of the other party.
2. Each Party shall undertake not to use, disclose or transfer information and documents exchanged between them except for the purposes for which they are assigned as agreed under this Memorandum, unless such disclosure is to be made to governmental or judicial entities at the official request of the Government or the judiciary.

Article VI: Amendment

In any event, all the provisions of this memorandum shall be subject to continuous review. The parties may, on the basis of a written agreement, modify or cancel any of the items contained therein, or add other items. The amended or added items shall be an integral part of this memorandum.

Article VII: Correspondence

Correspondence between the Parties shall be by registered mail, by hand delivery, fax or e-mail with written confirmation of receipt in all cases at the addresses specified in the issuance of this Note to both Parties, and in the event that any of the addresses are changed, the Party which has made the change shall notify the other Party within (10) days from the date of this change, otherwise all correspondence will be deemed valid and effective if the new address is not notified within this time limit.

Article VIII: Nature of the obligation

This memorandum contains no obligation that creates any kind of partnership, partnership or agency relationship between the Parties or any relationship between them that entails any obligations except as specifically agreed in this Convention.

Article IX: Termination of the MOU

In the event that either "party" breaches its obligations arising from the application of the texts of this memorandum, the other party may give notice to the breaching party indicating its wish to terminate this memorandum. Unless this is fixed during

(30) days from the date of submission of this notice, the other party may then terminate this Convention by providing written notice to the breaching party.

Article X: General provisions

- 1- Neither party shall be held liable to the other for any failure or delay in the implementation of its obligations under this memorandum if it is due to force majeure, and the party affected by force majeure shall notify the other party in writing during 30 days after the occurrence of those reasons and the statement of reason, as well as reasonable efforts to remove them, the parties shall agree to amend or terminate the memorandum if the force majeure situation continues for more than 6 months.
- 2- This memorandum is governed by the regulations in force in Saudi Arabia and is interpreted under these Regulations and in the event of any dispute concerning the interpretation or implementation of this memorandum being settled amicably.
- 3- The present memorandum is not binding, is based on joint cooperation for the parties' interests and does not entail any obligations to confront the parties.
- 4- In the event of a defect or invalidity in any of the conditions or obligations set forth in this memorandum, the defect or invalidity shall be limited to the scope of the clause or obligation contained therein and shall not exceed any of the terms or clauses of the memorandum in whole or in part. The defect shall be remedied or the exclusive part of the invalidity shall be eliminated and the remaining provisions shall apply.
- 5- Neither party shall authorize nor waive any of its rights or obligations contained in this memorandum to a third party without the other party's written consent thereto.
